**Introduction:**

Provision of an amount of Rs.13,88,000,00-00 (Rs. Thirteen Crore Eighty-eight Lacs) for the purpose of providing treatment to children suffering from juvenile diabetes under the school health program in the state and for the purpose of examination. A new provision for the year 2023-24 has been made in the budget of the Department of Health and Family Welfare. The proposal made by the Additional Director (AD), Office of the Commissioner (Health), Gandhinagar vide letter dated 10/4/2023 at number - (2) in the above reading for giving administrative approval to said provision was under the consideration of the Government.

**Resolution:**

Rs.13,88,000,00-00 (Rupees Thirteen Crore Eighty Eight Lacs only) for the year 2023-24 New Affairs Health and Family to provide timely diagnosis and treatment to children suffering from juvenile diabetes under school health program in the state at the end of adult consideration. Administrative approval is hereby granted to the proposal of the Additional Director (Public Health), Office of the Commissioner (Health), Gandhinagar, subject to the following conditions, to the amount of provision made in the budget of the Welfare Department.

**Beneficiary:-**

- 1.1 The scheme covers all persons with Juvenile Diabetes (Type-1 Diabetes) living in rural and urban areas (Municipal Areas, Municipal Areas and Notified Areas) of all districts of the State.

**Benefits given to the beneficiary:-**

- 2.1 Facility for regular free diagnosis and treatment of all patients with Juvenile Diabetes (Type-1 Diabetes).
- 2.2 The said treatment shall mainly include the following free treatment.
  - Free primary diagnosis, identification and registration of patients up to 18 years through School Health National Child Health Program Mobile Health Team
  - Regular free diagnosis and treatment of patients in the age group above 18 years by Community Health Officer (HWC) at village level and Medical Officer (HWC) at urban level
  - Free treatment of complications
  - Incorporating a three-tiered treatment
  - Counseling services
  - For wide publicity of the scheme, publicity, dissemination activities like-advertisement, pamphlets, posters, hoardings etc.- have to be done.

**Implementation:-**

- 3.1 School health at the state level should implement the entire scheme through the National Child Health Programme.
- 3.2 School Health - Children with Juvenile Diabetes (Type-1 Diabetes) will be identified and registered during the screening program for all children up to 18 years through the National Child Health Program mobile health team.
- 3.3 Identification, routine diagnosis and treatment of patients with Juvenile Diabetes (Type-1 Diabetes) in the age group above 18 years by Community Health Officer (HWC) at village level and Medical Officer (HWC) at urban level

- 3.4 The Medical Officer has to ensure that all children under treatment receive regular treatment.
- 3.5 Medical Officer PHC/UPHC shall take help of CHO HWC (Rural Level) and M.O HWC (Urban Level) for the said operation.
- 3.6 All these children will be referred to Pediatrician/physician and they will conduct necessary examination and start treatment.
- 3.7 The RCHO at the district level will be the District Nodal Officer of the scheme and will function under the guidance of the Chief District Health Officer.
- 3.8 State Grievance Redressal Committee and District Grievance Redressal Committee shall be constituted at State level as well as District level for the purpose of grievance redressal under this scheme.
- 3.9 Necessary guidelines and implementation guidelines for smooth implementation of the scheme shall be issued from time to time.

**Conditions regarding approval of new scheme:**

- A. The scheme shall disburse assistance only within the limits of the designated beneficiaries and within the limits of the budgetary provision. In any case, the department has to take care to plan accordingly that the financial limit and the number of beneficiaries do not increase under this scheme.
- B. The scheme shall be implemented through the office of the Commissioner (Health) under the Department of Health and Family Welfare.
- C. Beneficiary shall be selected following a transparent process
- D. Online application and approval shall be provided
- E. In case of supply of equipment or kits, the purchase shall be made through the Government e-Marketplace (GeM) portal and the instructions for purchase as per purchase procedure shall be strictly followed. And should be purchased accordingly. But for the purchase of items which are not available on GeM Portal, as per the resolution dated 01/10/2018 of the Department of Industries and Mines, the purchase must be made only after obtaining a No Objection Certificate from the Department of Industries and Mines. Subsequent revisions from time to time have to be strictly followed. The quality of the equipment/ kit has to be ensured.
- F. Financial assistance shall be disbursed through DBT method only at prescribed intervals  
The Scheme shall be compulsorily registered on the DBT Portal.  
Scheme has to be linked with H.C.M Dash Board.
- I. Proper arrangements for monitoring of the scheme have to be made.
- J. Social Audit and Third Party Verification should also be done from time to time and submitted to the Government
- K. Expenditure has to be done within the limits of planned manpower.
- L. In a Centrally Aided Scheme, the scheme benefit shall be disbursed to the beneficiary as per the allocation of funds by the Central Government.
- M. Orders of the State Government should be obtained if any changes are to be made in the norms and amounts of assistance of the existing scheme.
- N. The expenditure incurred under this sanction shall be subject to the budgetary provision of that year and within the limits of the grant allotted by the Finance Department from time to time.
- O. Adequate budgetary provision has to be made for the present work in the current and next financial year subject to existing rules.
- P. Expenditure in this regard shall be made in prescribed manner as per the provisions of the State Government's standing and applicable resolutions/circulars and rules from time to time.
- Q. The principles of financial fairness have to be applied to the expenditure incurred on this approval.
- R. The grant allocated under this sanction cannot be used for any other purpose. The remaining amount has to be surrendered at the end of the year.
- S. Conditions prescribed under the scheme have to be strictly adhered to
- T. In case of non-expenditure for three consecutive years under the above administrative sanction, the administrative sanction shall be automatically cancelled.
